For fees and expenses of jurors as authorized by 28 U.S.C. 1871 and 1876; compensation of jury commissioners as authorized by 28 U.S.C. 1863; and compensation of commissioners appointed in condemnation cases pursuant to rule 71.1(h) of the Federal Rules of Civil Procedure (28 U.S.C. Appendix Rule 71.1(h)), [\$50,750,000]\$51,851,000, to remain available until expended: *Provided*, That the compensation of land commissioners shall not exceed the daily equivalent of the highest rate payable under 5 U.S.C. 5332.

#### **GENERAL STATEMENT AND INFORMATION**

This appropriation provides for the statutory fees and allowances of grand and petit jurors, and for the compensation of jury and land commissioners. In addition to reimbursement for daily travel to and from court, expenses allowed include meals and lodging furnished to sequestered jurors, and transportation to view evidence or crime scenes offsite. Budgetary requirements depend largely upon the volume and the length of jury trials demanded by parties to both civil and criminal actions and the number of grand juries convened by the courts at the request of United States Attorneys. All these factors are outside the control of the judiciary.

The fiscal year (FY) 2020 request of \$51,851,000 for the Fees of Jurors and Commissioners account will support all projected requirements for petit and grand jurors and land commissioners.

#### **Petit Jurors**

A petit jury may be called to hear a trial in a criminal or civil action. A criminal trial normally has a 12-person jury and a civil trial typically has a 7- to 9-person jury. Criminal juries decide whether the defendant committed the crime as charged. In a civil trial, the jury's responsibility is to decide whether the defendant injured or otherwise failed to fulfill a legal obligation to the plaintiff and to determine what the compensation should be. Petit jurors are entitled to a daily attendance fee of \$50 for each day of their jury service. In FY 2018, Congress approved the judiciary's request to increase the daily petit juror attendance fee from \$40 to \$50.

The number of jurors called on any given day to serve in a petit jury pool is related to the number and type of cases in which a jury trial is requested. Moreover, under rules of criminal procedure, criminal trials are allowed additional peremptory challenges compared to civil trials because of the jury size. This means that the court must take these challenges into account when determining the number of potential jurors in a criminal jury pool. However, a correspondingly larger number of prospective jurors in the criminal pool will not be selected to serve on the trial due in part to the additional peremptory challenges. Thus, when compared to civil jury selections, the total number of prospective jurors completing jury service during jury selection is greater in criminal trials.

In FY 2018, the total number of available petit jurors<sup>1</sup> increased by 2.5 percent to 357,004, ending a 10-year decline in available petit jurors. Available petit jurors are projected to decrease to 353,000 in FY 2019 and further decrease to 339,000 in FY 2020. This trend is driven largely by fewer filed cases proceeding to a jury trial. Similarly, trial days are estimated to decrease in FY 2019 and

FY 2020. Table 6.1 on page 6.7 provides a historical pattern of the number of juror days, number of jurors called, and the related costs of those jurors' expenses.

#### **Grand Jurors**

A grand jury is a jury of inquiry whose duty is to receive complaints and accusations in criminal cases, hear the evidence presented on the part of the Government, and find bills of indictment in cases where the jurors are satisfied that the evidence presented is sufficient to warrant filing an indictment and bringing the case to trial. The number of grand juries convened by district courts varies depending on such factors as the number of criminal cases, the type of criminal activity, and the number of places in which court is held. Grand juror activity is measured by the number of sessions convened, jurors in session, and total jurors in attendance. Grand jurors are entitled to a daily attendance fee of \$50 for each day of their jury service. Like petit jurors, in FY 2018, Congress approved the judiciary's request to increase the daily grand juror attendance fee from \$40 to \$50.

In FY 2018, the total number of available grand jurors<sup>2</sup> increased by 1.5 percent to 179,740. Available grand jurors are projected to continue to increase in FY 2019 to 180,100 and then decrease again in FY 2020 to 178,100. Overall, the downward trend of criminal case filings is reflected in the decline of grand jury sessions convened. Table 6.2 on page 6.8, provides further detail on grand jury activity.

### FISCAL YEAR 2019 APPROPRIATIONS ASSUMPTION

In the absence of enacted full year FY 2019 appropriations, the judiciary made assumptions to construct a FY 2020 budget request. The judiciary built the FY 2020 budget request for the Fees of Jurors and Commissioners appropriation assuming the FY 2019 reestimate of \$50,750,000. This amount funds FY 2019 standard inflationary adjustments.

After full year FY 2019 appropriations are enacted, the judiciary will re-estimate its FY 2020 budget request and transmit to the Appropriations Committees any changes to FY 2020 appropriations requirements.

For bill language, the judiciary used the language from H.R. 6147, the House-passed FY 2019 Financial Services and General Government (FSGG) appropriations bill, updated with the assumed funding level as described above, as the closest approximation of eventual enacted FY 2019 appropriations language.

#### **Land Commissioners**

The responsibility of land commissioners is to determine the issue of just compensation arising from the deprivation of private property for public use. Under the Federal Rules of Civil Procedure, a district court may use its discretion to order that compensation for condemned property be determined by a commission of three persons appointed by the court. The determination of compensation is based on evidence presented during the exercise of trial procedures and evidentiary rulings. This delegation of the judicial function requires close judicial supervision and requires that actions taken by the commission be fully documented to permit full review by the district or appellate courts. This system ensures due process of law to the litigants.

Land commissioners are compensated based on the daily equivalent of the highest rate payable under 5 U.S.C. § 5332. They are also eligible for locality pay amounts that apply to their locality pay areas which are payable in addition to their basic pay. The annual adjusted pay rate (i.e., basic pay plus locality pay) for land commissioners is limited to the rate of pay for level III of the Executive Schedule, currently \$174,500.

### **JUSTIFICATION OF CHANGES**

The FY 2020 appropriation request for Fees of Jurors and Commissioners totals \$51,851,000, which represents an increase of \$1,101,000, or 2.2 percent, above the FY 2019 assumed appropriation of \$50,750,000. The amount requested is for adjustments to base to maintain current services.

# A. ADJUSTMENTS TO BASE TO MAINTAIN CURRENT SERVICES

#### 1. Inflationary adjustments

#### a. Grand Jurors

Requested Increase: \$169,000

An increase of \$169,000 is requested for inflationary adjustments associated with grand juror costs, including travel allowances (mileage, parking, tolls), meals and lodging for sequestered jurors, and other miscellaneous juror expenses.

#### b. Petit Jurors

#### Requested Increase: \$319,000

An increase of \$319,000 is requested for inflationary increases associated with petit juror costs, including travel allowances (mileage, parking, tolls), meals and lodging for sequestered jurors, and other miscellaneous juror expenses.

### 2. Adjustment to base to requirements in FY 2019

Requested Increase: \$1,051,000

An increase of \$1,051,000 is requested to reflect a base adjustment to FY 2019 requirements in the petit juror program. The FY 2019 assumed level funds these requirements at a lower level than actual petit juror activity and revised, projected caseload anticipated in FY 2019.

### 3. Projected change in available jurors

#### a. Grand Jurors

Requested Decrease: (\$192,000)

A decrease of \$192,000 is the result of a projected decline in the estimated number of available grand jurors from FY 2019 to FY 2020.

#### b. Petit Jurors

#### Requested Decrease: (\$246,000)

A decrease of \$246,000 is the result of the projected decline in the estimated number of available petit jurors from FY 2019 to FY 2020.

# 4. Anticipated carryforward from FY 2019 and prior years into FY 2020 $\,$

Estimated funds available: \$1,000,000

The judiciary projects \$1,000,000 will be available through anticipated savings to carry forward from FY 2019 and prior years into FY 2020 to offset the FY 2020 appropriations request for the Fees of Jurors program. The judiciary will advise the appropriations subcommittee staffs of changes to this estimate.
